

IT IS HEREBY ORDERED AS FOLLOWS:



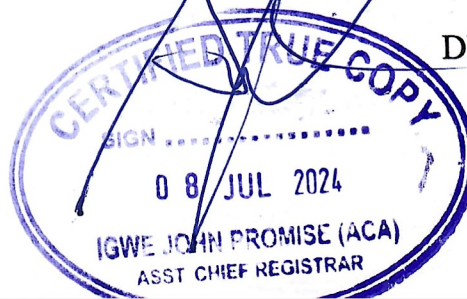

2. That the parties to this suit are hereby directed to maintain the status quo ante litem in this suit as at 5th July 2024 pending the hearing and determination of the motion on notice for interlocutory injunction already filed herein.
3. An Order is hereby made for substituted service of the originating and other processes in this suit on the 1st – 30th Defendants by pasting the same at the gate of the Rivers State House of Assembly Quarters, opposite former NDDC headquarters, off Aba Road, Port Harcourt, Rivers State.
4. That this matter is hereby adjourned to the 15th day of July 2024 for the motion on notice for interlocutory injunction
